### AAO Delegate Report - Dr. Chris Howell

Discussion on government task force. Looked at the AAO and opinion on what to change and modify. Diversity of delegation is an area for improvement. A discussion on diversity took place. At the AAO level International membership must be members of WFO. After year 1 year the WFO membership can be dropped. A tasked force to be assembled for what functions international members can have. Including the roles an international member may have are to be reviewed. A plan to review the geographic boundaries and make-up of the components was once again proposed and defeated. Legal defense fund is set up at the AAO. Annual dues remained the same.

#### KAO Director Report - Dr. Jeri Stull

Dr. McCamish created liquid reserves to make member feel programs are working for SAO. Dr. Inman spoke about professional efficacy. The SAO had an outstanding group of orthodontists in the leadership class for 2015. They represented diversity in practice models, gender and years since graduation. Two new items that have come under the direction of our new Executive Director will be part of the fall meeting this year: Orthovation and Give Kids a World Village. ABO director started the process for replacing current director. Debate about the journal should be print or electronic.

#### SAO Executive Director - Ms. Heather Hunt

Publication policy of 4 newsletters per year and 14k per mailing. The publication is moving towards a clinical style and possibly moving to a longer publication 2x year and 2x electronic publication. An opt out of paper will be sent each year. By opting out there will be a cost saving. Three SAO three staff positions changed this past year. Management contracts provided by SAO to cover management of components are being offered. This would include all meetings and programs. Including meeting negotiations with vendors. Negotiations hotels and possible improved deals. SAO is currently managing the VAO. Books will stay with Treasurer.

New innovation with a booth (Orthovation) in the shape of an orthodontist office. Vendors will place technology in the booth. No vendor representative involvement.
